## Order

NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Sabuj Primary Teachers Trainig Institute, Plot.No-1801, Po-Nandakumarpur, Tehsil/Taluka-Mathurapur-II Block, Dist-South 24, Parganas(WB), West Bengal-743349 for conducting D.El.Ed. Course of Elementary (level) of two year duration with an annual intake of 50 (fifty) from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009.
- 4. The recognition is subject to fulfillment of the following:

  - d. Recognition letter
  - e. Information for having fulfilled the norms & standard and other required conditions.
- 5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
- 6. Further, if the institution is not satisfied with the order, they may prefer an appeal under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <a href="https://www.ncte-india.org">www.ncte-india.org</a> within 60 days of the issue of the order.
